





INVITATION TO BID

The City Government of Puerto Princesa (CGPP) hereby invites all interested parties, Natural or Juridical Filipino Person, to bid for the:

GRANT OF FRANCHISE TO OPERATE A COCKPIT IN THE POBLACION AREA OF PUERTO PRINCESA CITY

The qualification criteria of any and all interested bidders must be in accordance with **Section 3F.02 of Ordinance No. 397** [Revised Revenue Code of Puerto Princesa City of 2008], enacted by the SP of Puerto Princesa, which states as follows:

“Section 3F.02. Qualification of the applicant/s. The following shall be qualified to apply for the grant of Franchise to operate a Cockpit in the City of Puerto Princesa:

1. *Any person of legal age, Filipino citizen, natural or juridical person, 100% Filipino capital, in case of juridical person must be duly incorporated under existing Philippine Law;*
2. *Applicant/s, natural or juridical, must submit the following:*
 - a) *Financial Statement duly signed by an Accountant showing the net worth of not less than One (1) Million for the Current Year;*
 - b) *Income Tax Returns (ITRs) for at least three (3) previous years. For newly organized/registered Corporations or Cooperatives, at least the latest ITR shall be required; and*
 - c) *Certification of Bank Deposit with the minimum amount of Five Hundred Thousand (P500,000.00) Pesos or Credit Line in any of the reputable financial institutions with a minimum amount of One Million (P1,000,000.00) Pesos.”*

Any and all bids to be submitted shall have a **Lower or Floor Bid Ceiling of Two Million Pesos (P2,000,000.00)**, pursuant to and in accordance with **Ordinance No. 585**.

The public bidding to be conducted shall be undertaken and administered by the **Bids and Awards Committee for the Conduct of Bidding for the Grant of Franchise to Operate a Cockpit in the City of Puerto Princesa [BAC – COCKPIT]**, organized by virtue of **Administrative Order No. 21-A**, dated March 3, 2014, issued by the undersigned pursuant to Sangguniang Panlungsod of Puerto Princesa Resolution No. 58-2013 [A Resolution Respectfully Requesting the Honorable City Mayor Lucilo R. Bayron to Direct the Bids and Awards Committee (BAC) to Expedite the Conduct of Bidding for the Franchise to Operate a Cockpit in the City Puerto Princesa].

Venue of submission, in accordance with the above schedule, shall be at the Conference Room 1, 2/F Puerto Princesa City Hall Complex, Sta. Monica Heights, Puerto Princesa City.

The activity of the BAC – COCKPIT shall be in accordance with the procedural guidelines set forth in the **Instruction to Bidders and Terms of Reference (Instruction and TOR)** to be issued as forming part of the **Bidding Documents**.

The ABC shall be the upper limit or ceiling for acceptable bid prices. If a bid price, as evaluated and calculated in accordance with the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184 [Government Procurement Reform Act], is higher than the ABC, the bidder submitting the same shall be automatically disqualified. There shall be no lower limit or floor on the amount of the award.

Bidding will be conducted through open competitive bidding procedure using a non-discretionary "pass/fail" criterion as specified in the IRR of RA 9184. All bids must be COMPLETE. Partial bids shall be considered non-responsive and, thus, automatically disqualified. In this regard, where a required item is provided, but no price is indicated, the same shall be considered as non-responsive, but specifying a "0" (zero) for the said item would mean that it is being offered for free to the CGPP.

Bidding is restricted to those specifically enlisted under **Section 23.5.1.1** of the IRR of RA 9184.

All particulars relative to Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference, Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of Republic Act 9184 and its Implementing Rules and Regulations (IRR).



The CGPP reserves the right to reject any and all bids, to waive any required formality in the bids received, provided that such waiver does not refer to a major deviation in a bid and accept only such bids which are advantageous to the government. The CGPP assumes no responsibility whatsoever to compensate or indemnify bidders for any expenses incurred in the preparation of their bids.
